

Sub: Scrutinizer's Report for passing of resolution through Postal Ballot (physical and e-voting).

I, Krishna Rathi (Membership No. FCS 9359) Proprietor of M/s Krishna Rathi & Associates, Practicing Company Secretary was appointed as Scrutinizer by the Board of Directors of the Company to scrutinize the voting through Postal Ballot (physical and e-voting) for seeking approval of members for Migration of Listing / Trading of Equity Shares of the Company from NSE Emerge to Main Board of the National Stock Exchange of India Limited.

As per provisions of applicable rules of Companies (Management and Administration) Rules, 2014, the Company has published advertisement about completion of dispatch of Postal Ballot Notice and providing E-voting facility in English Newspaper "Express Network" on 28<sup>th</sup> November, 2021 and Hindi Newspaper "Business Standard" on 29<sup>th</sup> November, 2021.
- 3. Particulars of all the Postal Ballot Forms received from the Members have been entered in a register separately maintained for the purpose.
- 4. All Postal Ballot Forms received upto 5.00 p.m. on Tuesday, 28<sup>th</sup> December, 2021, being the last date and time fixed by the Company for receipt of the Postal Ballot Forms, are considered for my scrutiny.
- 5. The Postal Ballot Forms were duly opened and scrutinized, including verification of signature of the shareholder(s). The Shareholding was matched/ confirmed with the Register of Members of the Company/ List of Beneficiaries maintained by the Depositories as on the cut-off date i.e. Friday, 19<sup>th</sup> November, 2021.
- 6. The e-voting period commenced on Monday, 29<sup>th</sup> November, 2021, 9:00 a.m. (IST) onwards and ended on Tuesday, 28<sup>th</sup> December, 2021 at 5.00 p.m. (IST). The Company had availed the evoting facility offered by National Securities Depository Limited (NSDL) for conducting Postal Ballot Process.
